## **INSTRUCTIONS**

This contract incorporates the terms and conditions of Invitation for Bids (IFB) 959 SET-ASIDE FOR SMALL BUSINESSES – Duty Wear: Holsters, Belts and Accessories, issue date 01/7/2008. eVA procurement folder 24786.

1. **ORDERS:**

- A. Unless otherwise instructed by the Division of Purchases and Supply, all departments, institutions and agencies of the Commonwealth of Virginia must order items/services through eVA.
  - B. If this contract is authorized for use by localities, Virginia cities, counties, towns and political subdivisions, orders will be placed through eVA to the maximum extent possible.
2. The applicable contract number, federal employer identification number (FEI), and item number (for itemized contracts) must be shown on each purchase order and copy, each facsimile transmission or given verbally when telephonic orders are placed.
3. Inspection on delivery and approval of vendor's invoice is the responsibility of receiving state agency, Virginia city, county, town or political subdivision.
4. Any complaint as to quality, faulty or delinquent delivery, or violation of contract provisions by contractor shall be reported to the Division of Purchases and Supply.
5. **Renewals.** This contract contains three (3) successive one-year renewal options.
6. **Price Adjustments.** During the current term of the contract, price escalation may be allowed every 365 days, if justified. The contract officer makes the decision to allow or deny a request for increase based upon the documentation submitted by the contractor. The contractor is required to pass on any price reductions immediately. **IMPORTANT!** All price increases must be approved by the contract officer. Contract changes will be posted at [www.eva.virginia.gov](http://www.eva.virginia.gov).
7. Minimum orders shall be \$100.00 for F.O.B. Destination to ordering agency or other public body within the Commonwealth of Virginia. For orders of less than \$100.00, the contractor will be permitted to add actual transportation cost (prepaid) to invoice for payment, or the agency may purchase such order off contract from other sources. Partial shipments of less than the minimum order value which are made at the option of the contractor shall be made F.O.B. Destination with no transportation charges added. If at the agency's request shipments are below the minimum order value, the contractor may add actual transportation cost to invoice for payment.
8. **CONTRACTOR'S MONTHLY REPORT OF SALES:** Contractors shall provide electronic reports in Microsoft Excel format on a monthly basis showing invoiced sales data. Reports are to be provided no later the 10th of each month, reporting

total invoiced sales and returns transactions that took place in the immediately prior month. Monthly reports shall be sent to the contract officer. Consistent report tardiness may be cause for contract termination.
