INSTRUCTIONS

1. **Purchase orders will be submitted to the contractor via the Commonwealth of Virginia's electronic procurement system, also known as Eva. The orders will be governed by this agreement and the terms and conditions contained in the separate agreement for participation in Eva executed by the contractor. If this contract is authorized for use by localities, Virginia cities, counties, town and political subdivisions may use this contract only if the orders are placed through Eva.**
2. Inspection on delivery and approval of vendor's invoice is the responsibility of receiving state agency, Virginia City, county, town or political subdivision.
3. Any complaint as to quality, faulty or delinquent delivery, or violation of contract provisions by contractor shall be reported to the Division of Purchases and Supply for handling with the contractor. Form "Complaint to State Vendor" (DGS-41-024), by which to facilitate the notification of the contractor and this office of complaints, is available from the Division of Purchases and Supply website www.dgs.state.va.us
(Click on DPS icon, click on DPS forms).
4. **Contract extension for six (6) month period.**
5. Any changes whether for increases or decreases in pricing, delivery terms or additional options must be approved by the Division of Purchases and Supply in advance of issuance of the purchase order. Disputes between the ordering agency and the vendor will be resolved in accordance with the terms of the contract and any change orders/renewals unless prior approval was granted by DPS.
6. This contract was bid by the vendor with the understanding that the dealer is not required to maintain an inventory of vehicles for this contract. The dealer factory orders the vehicles. Thus, purchasers are encouraged to order vehicles early in the contract cycle. The build out date is the last date that a dealer can order a vehicle. This date is some times adjusted by the manufacturer due to production changes. Please check the build out date before ordering.
7. If you need to cancel an order, cancel it early in the process. After a vehicle has been on order for a short time, (usually about 10 days), the manufacturer will not accept a cancellation.

PATROL VEHICLE CHEVROLET IMPALA SPECIFICATION, 2008 Model Year

The primary user of this contract will be the Virginia State Police; however, this contract will be opened to all law enforcement agencies of the Commonwealth and its political subdivisions.

All components, unless otherwise required by these specifications, shall be the standard or optional equipment specifically advertised and provided by the manufacturer of the vehicle. The sole source of information in determining whether or not the equipment is specifically advertised for the vehicle being offered shall be the manufacturer's published police vehicle literature.

Any equipment called for in these specifications which is not listed by the manufacturer as standard or optional for the model being offered is subject to buyer approval. Vehicles and equipment must conform to the requirements set forth below. Minimum requirements are stated and may be exceeded, subject to buyer approval.

Base Vehicle: Chevrolet Impala, 4 door sedan, with optional 9C1 police package, 2007

Wheelbase: 110.5 inches.

Engine: Minimum 3.9 liter V6, sequential fuel injection, 240 horsepower.

Transmission: Automatic electronic overdrive.

Axle Ratio: 3.29.

Cooling System: High capacity cooling with extended life coolant.

Alternator: 125 amp.

Battery: 690 CCA.

Tires: P225/60 R16 SBR Blackwall "H" rated with full sized spare.

Wheels: 16" X 6.5 steel with steel full size covers.

Suspension: Firm ride and handling.

Brakes: 4 wheel antilock disc.

Seat: Heavy duty front bucket seats with security panel, cloth, heavy duty rear seat, cloth.

Speedometer: Analog, certified accuracy, 1 MPH increments.

Dash light controls: On/Off switch for speedometer light, daytime running lights and radio display.

Top Speed: 124 MPH minimum.

Locking System: Single key to operate all locks with random codes for each vehicle ordered. Power controlled locks, with child safety lock on rear doors. Three (3) keys shall be provided for each vehicle.

Remote keyless entry.

Auxiliary power outlet: 100 amp in trunk. 100 amp ignition and main power supply wiring at instrument panel.

Air Conditioning: Factory installed with 134A refrigerant.

Glass: Tinted, solar ray glass, all windows.

Radio: AM/FM stereo with CD player

Restraint system: Driver and passenger air bags, driver side impact air bag.

Steering Wheel: Tilt column.

Truck release: Electric mounted to left of steering column, ignition feed.

Windows: Power with rear window lockout switch.

Wipers: Intermittent with washer system.

Mirrors: Dual outside electric controlled.

Cruise control: Mounted on steering wheel.

License plate brackets: Front & rear.

Floor mats: Front and rear, color keyed, OEM only.

Spot lamp: Left hand.

Auxiliary equipment tray: #K012-11.

Dome light: Night saver.

Special Paint: 2 tone color optional AAT, W/Car SEO color scheme #W006 Option Code 1PF.

Interior color: Blue.

Bonding straps: 1" braided metal installed at each hood hinge, trunk hinge, exhaust system, engine to chassis.

Trunk light switch: On/Off switch on trunk light circuit located inside trunk compartment.

Anti-theft System: Tremco.

Pilot Vehicle: **(This paragraph applies to State Police orders only.)** One vehicle must be available for approval by purchaser before the remainder of order is produced. All expenses with the pilot inspection are the responsibility of the successful bidder.

Emblems: Any advertising emblem or decal may not be displayed on the vehicle.

Publications: All owners' manuals, warranty manuals, certificate of origin, etc., must accompany vehicle when

delivered. Each vehicle must be invoiced separately.

Service Manuals: One complete set of service/shop manuals and wiring diagrams for the current model year shall be delivered with the first car delivered to Virginia State Police.

Pre-delivery inspection: Each vehicle must be delivered clean, complete and ready for service including a current Virginia State Inspection. Each new vehicle service preparation must be performed by the dealer according to the manufacturer's specifications. Vehicles delivered without proper dealer preparation must be picked up, serviced and

re-delivered by the dealer at his expense. Proper dealer preparation shall be evidenced by a complete manufacturer's pre-delivery inspection form for each vehicle and signed by a representative of the dealership.

Warranty: The warranty period shall begin when the vehicle is placed in service rather than at the time of delivery as evidenced by the purchaser's records.

Emissions Certifications: The vehicle shall meet all emission standards applicable to all regions of the Commonwealth.

Radio Noise Suppression: All vehicles will be equipped by the purchaser with a high band VHF (150-160MHZ) and low band (39MHZ) two way radio. The vehicle operation must not be degraded due to the operation of 100 watt transmitters into an antenna system with a VSWR of 2:1. The VHF receivers must not be degraded due to EMI/RFI from electrical/electronic systems of the vehicle.

1. All vehicles are to be delivered during regular business hours between the hours of 8:00am to 3:00pm.
2. Vehicles shall not be delivered during State Holidays.
3. All other deliveries must be approved in advance by the purchaser.
4. Each vehicle will be checked for compliance to these specifications.
5. If any deviations, shortages, damage, or poor workmanship is noted the invoice will not be approved for payment until all defects are corrected by the dealer.

OPTIONS: Unless an option is specifically identified in the bid as a dealer installed option, all options shall be factory installed. Further if the factory installed option includes more features than specified in the bid, the additional features shall be considered as required by the resulting contract.

Vehicle to be furnished shall conform to all applicable Federal and Motor Vehicle Safety Standards and all equipment shall conform to Title 46.2, Chapter 10, of the Code of Virginia and shall include a valid State Inspector Sticker. No dealer identifications such as sticker, decal, metal emblem and so forth will be accepted on automobiles furnished under this contract.

New vehicle preparation must be performed by dealer prior to delivery. Include in bid the cost of usual pre-delivery inspections.

WARRANTY: 36 Months or 36,000 Miles, Bumper to Bumper. The warranty period shall begin when the vehicle is placed in service rather than at the time of delivery as evidenced by the purchaser's records.

COLORS: All Vehicles shall be available in any of the manufacturer's standard colors.

TAXES: No Federal Tax is to be included in bid, including tires. Tax Exemption Registration number will be furnished.

LICENSE: Thirty day license tags shall be furnished with the vehicle.

TITLE PAPERS: All papers for titling purposes shall be delivered with the vehicle.

DELIVERY: Vehicles shall be delivered to the various state agencies, cities, counties, towns, and political subdivisions throughout the State as required.

1. The ordering entity will pay .060 cents per mile for mileage in excess of the distance from the dealer's location to 1111 E. Broad Street, Richmond, Virginia 23219.
